Notes / Instructions :-

1. For the vacancy of the Chairman, the candidate, the proposer and the seconder can be from any category having voting rights.
2. In case of Founder, Life and Ordinary member categories, the candidate, proposer, and the seconder should belong to the same category.
3. In case of Institutional and Corporate members, no proposer or seconder is required.
4. Associate, Student, Associate Life, Institutional Associate and Associate Corporate members are not eligible either to contest for any post or propose or second any candidate or exercise vote.

5. A brief Bio-data of the candidate, not exceeding 500 words may be sent by e-mail (admin@intach.org) and alongwith the nomination form for circulation to Members along with the Ballot Papers. Bio-data exceeding 500 words will be abridged by INTACH.
6. Official stationery, INTACH name & logo and official position of the candidate cannot be used by the members in their individual capacity and for canvassing of votes for election to the Governing Council.
7. The members using official stationery, INTACH name & logo and official position will be disqualified after due enquiry for a period of 3 years for contesting election to the Governing Council. In the event of the use of official stationery, etc. coming to INTACH notice subsequent to the counting of the votes, the elected candidate(s) will stand disqualified and the next candidate(s) will be deemed to be elected to the Governing Council.
8. INTACH employees are not eligible to contest the election to the Governing Council.
9. The election is a democratic process, canvassing by the candidate himself through emails, letters, SMS, post cards, etc. is permitted. The candidate should not make any negative propoganda against the other candidates while canvassing his own candidature. Candidates should not use political, social or any other kind of pressure. Canvassing, in the form of sending emails, letters, SMS, post cards, etc., by Convener/ Co-Convener/any other member on behalf of any candidate is not permitted. However, Conveners/Co-Conveners/any other member may otherwise endorse the positive attributes of any candidate.
10. In case of canvassing by any person for election to the Governing Council members, no promises on quid pro quo basis can be made involving financial implications or otherwise either from personal funds or from INTACH's resources.
11. The voting members will have the liberty to use the following methods to post back the ballot papers:
 - (a) by using the Business Reply Article envelope sent by INTACH without any postage charges, or
 - (b) the same envelope can be sent at their own cost by any one of the following modes – (i) Registered Post (ii) Speed Post (iii) Courier.
12. While there will be no compulsion to vote for the vacancies in a particular category, the members are advised as a part of the election bye-laws that the voting member should preferably tick-mark the names of the candidates equal to the number of vacancies.
13. A ballot paper with tick-marking of the candidates more than the number of vacancies will be treated as invalid.
14. A ballot paper with cross marking (x) against the name of the contestant will be treated as invalid.
